GOVERNMENT FEES

Apllication fee

581,76 € - paid by main applicant and same value paid by additional family members. This fee must be paid before the submission of the GV application.

Issue Fee

5.812,11 € - paid by applicant once the application is approved.

Renewal fee

2.906,61 € - renewal of residence permit.

LEGAL FEES

5.000 € to 10.000 € - Fees vary according to the legal offices and type of Investment you choose.

PROPERTY PURCHASE TAXES

9.3% is the total amount of taxes you will pay of your Investment.



REQUIRED DOCUMENTATION

- Passport or any other valid travel document;
- Evidence of entry and legal stay in the Portuguese Territory;
- Proof of Health Insurance valid in Portugal;
- Criminal record from country of origin, or of the country (or countries) where the applicant is living for more than one year;
- Supporting evidence of the tax identification number, or equivalent, of the country of origin, residence or tax residence;
- Filling in the Application Form (standard form) stating the authorisation for consultation of the Portuguese Criminal Record;
- Sworn Statement by which the Applicant declares to comply with all the minimum quantitative and time requirements (five years) for the investment activity in the Portuguese Territory.
